NOTICE OF ELECTION OF EIGHT (8)
MEMBERS OF THE PHARMACY
COUNCIL OF MAURITIUS

Notice is hereby given to all registered pharmacists that the election of eight (8) members of the Pharmacy Council of Mauritius, comprising three(3) members from the public sector; and five (5) members from the private sector, will be conducted by the Office of the Electoral Commissioner on **Saturday the twenty-seventh (27th) day of February, 2016**; and that the Returning Officer will receive the nomination of candidates for the said election on **Thursday the eleventh (11th) day of February, 2016**, next ensuing, between the hours of **10.00 a.m. and 2.00 p.m.** at the Office of the Electoral Commissioner, MaxCity Building, Level 4, Corner Remy Ollier and Louis Pasteur Streets, Port Louis.

Forms of nomination papers may be obtained **either** from the Acting Registrar at the Ministry of Health and Quality of Life, 8th floor, Emmanuel Anquetil Building, Port Louis or from the Health Director, Queen Elizabeth Hospital, Creve Coeur, Rodrigues, between the hours of 9.00 a.m. and 3.00 p.m. on working days (excluding Saturdays).

Every nomination paper must be supported in writing, by not less than **five** pharmacists and be delivered to the Returning Officer between the said hours of 10.00 a.m. and 2.00 p.m. on **11 February, 2016**.

Every nomination paper shall specify the name, address and date of registration of the candidate and also contain a declaration by the candidate that on nomination day:-

- (a) he is a citizen of Mauritius;
- (b) he is a pharmacist having not less than 7 years' experience as pharmacist in Mauritius; and
- (c) (i) he is not subject to, any preliminary investigation under section 27;
- (ii) no disciplinary proceedings are being held against him under section 28; and

(iii) no disciplinary measure has been taken against him during the last 5 years preceding the nomination.

Nomination Papers received by post, fax, email or otherwise will not be considered.

General Notice No. 114 of 2016

CENTRAL ELECTRICITY BOARD

In the exercise of the powers conferred upon it by Section 25 of the Central Electricity Board Act, the Board henceforth defines electricity consumers having installed a distributed electricity generation system on their premises as follows:

"Domestic Prosumer" is a Domestic Consumer, as defined in the General Notice No. 516 of 1964 and its subsequent amendments, who has installed and operates a distributed electricity generation system on its premises.

"Commercial Prosumer" is a Commercial Consumer, as defined in the General Notice No. 516 of 1964 and its subsequent amendments, who has installed and operates a distributed electricity generation system on its premises.

"Industrial Prosumer" is an Industrial Consumer, as defined in the General Notice No. 516 of 1964 and its subsequent amendments, who has installed and operates a distributed electricity generation system on its premises.

"Other Prosumer" is an electricity Consumer not qualified under the definition of Domestic Prosumer or Commercial Prosumer or Industrial Prosumer, who has installed and operates a distributed electricity generation system on its premises.

The above definitions take effect as from 1st September 2015.
